# **2023 CONFERENCE UPDATE**

Kay Kendall, MSW, LISW-s, CCTSW-MCS National Conference Chair

Three hundred social workers attended our 2023 STSW conference in San Diego the week of October 9<sup>th</sup>! The program began with a preconference workshop given by Dr. Scott Winder, Addiction in Organ Transplant on Monday, October 9<sup>th</sup>. Our keynote presentation, *Four Decades of Transplant Social Work* given by **Kay Kendall**, was the opening presentation on the first full day of the conference, October 10th. The evening of the 10<sup>th</sup> we gathered for the Welcome Reception, hosted by our Distinguished Sponsor, COTA. The 2<sup>1</sup>/<sub>2</sub> day program offered a number of general and breakout sessions. The setting was beautiful, the conference received positive feedback, and it was a wonderful opportunity to connect with other social

# **2023 CONFERENCE AWARD WINNERS**

Two awards, The *Lee Suszycki* and the *Judy Midelfort Memorial awards*, are presented at each annual conference to two members of the Society who have made significant contributions to the field of social work in transplantation. (To read more about Lee Suszycki and Judy Midelfort, click <u>here.</u>) Nominations are sought from the STSW membership. This year the *Lee Suszycki Memorial Award* went to two winners, **Beth Piotrowicz and** Kathy Dailey.



**Beth Piotrowicz** served for many years as a member of our conference planning committee. She was our first national program chair, and she developed this position. She

worked for a number of years by herself in this complicated process — call for abstracts, review of abstracts, CEU submission to NASW, complying required information — planning the program and problem solving many issues that arise when one is working with multiple presenters. Beth effected many improvements, resulting in a more efficient process. She is ending years of working in this position, a position which has required non-stop work twelve months of the year. Beth is a credentialed transplant social worker at Cleveland Clinic. After working with adults, she made a career change in 2020 –moving to children's programs, and also changing the organ group she works with. She has been a conference presenter and has been an active participant of the Cleveland Clinic Enterprise Initiative of pediatric to adult age transition, "On My Way". She displays energy, a positive attitude, a great sense of humor, an openness to work with colleagues, and a commitment that serves her patients and the Society with skill and heart.



Kathy Dailey is a credentialed social worker at Cincinnati Children's Hospital Medical Center. She has been a member of our conference planning committee as well as a co-chair of the program committee since

2015. In this role she, along with the conference planning groups, meets 12 months of the year. There are many steps to planning the program and Kathy's work is integral in shaping these pieces into a well-rounded conference program. During the time Kathy has served on this board position many changes have occurred. She has helped streamline the process, which has led to a more thorough review of the abstracts and improved the quality of presentations at our conference. While Kathy was involved in this work, she also made a major career change - continuing in transplant but changing from adult to a pediatric program and changing organ groups – a challenge that she wanted to take for her professional and personal growth. Kathy has presented at a number of our conferences and her presentations have been thought-provoking and well received. Kathy is always willing to step in and help and brings a sense of humor and fun to everything she does.

Emily Walz is the winner of this year's Judy Midelfort Memorial Award. Emily serves as a transplant social worker at UPMC in Pittsburgh, as well as the Outreach Coordinator for the

National Living Donor Assistance Center (NLDAC). Emily's passion for living donation and advocacy led her to spearhead an "NLDAC Process" that resulted in every potential living donor candidate being screened for NLDAC assistance, and for those who are eligible, helping those donors apply as part of their living donor work-up. Since implementing this process applications have doubled, and in 2022, \$285,937 in assistance was provided to living donors. The system has also proved to be sustainable and replicable. So far in 2023, over 101 applications have been submitted! Emily now trains other transplant centers on the UPMC NLDAC Process, which will result in other centers offering this assistance in a more organized way to all their eligible donors. Emily exemplifies excellence in transplant care, both to her patients and her transplant center. In 2020, Emily saw the need for a dedicated position to care for the living donors at UPMC, and began advocating for a dedicated living donor social work position. She researched, advocated, and developed a plan that was implemented. The position was approved and continues today. Emily continues this important work by actively serving on the STSW Living Donor committee. She treats every person with the utmost kindness, compassion and respect.

Please join us in congratulating Beth, Kathy, and Emily as this year's prestigious award winners.

 Mentor Committee – The Year of the Mentor Alexandra Radomsky, Chair

It was an immense privilege to attend this year's STSW Conference in San Diego, and to represent the Mentor Committee during those four days. I had the great pleasure of speaking with so many of our members about the positive impact of mentoring in our field and found it highly rewarding to witness the level of interest in this possibility. Our committee saw tremendous interest from STSW members in pursuing both mentor and mentee opportunities, as well as participating in our committee. We have sent further information about these opportunities to a number of potential mentors, mentees, Mentor Committee members. We encourage those we have contacted, as well as any other interested STSW members, to reach out to us at mentor@stsw.org to discuss further.

In addition to promoting the Mentor Program, I was pleased to be able to present data from a compilation of Mentor Program-focused surveys at the poster presentation session. This survey project sought to discover real-world outcomes and impressions of participating in a peer mentoring program and included input from 24 respondents. 100% of survey respondents felt their participation in the STSW Mentor Program was worthwhile, indicated they would choose to participate again, and would recommend participation to a colleague.

Other key takeaways from the surveys included mentee reports of gaining greater confidence in professional roles, expanding their clinical skills and resource portfolios, growing their professional networks, having a safe/nonjudgmental space to problem solve, process experiences, and practice interventions, as well as developing skills to manage difficult cases/unique scenarios. Mentors reported feeling the time spent volunteering was well-worth the investment and provided enrichment and additional opportunities to reflect on their own professional awareness, as well as being a rewarding experience overall.

Another project we were pleased to present at the conference was a Mentor Program video, which included first-hand accounts from mentees and mentors about the reasons they chose to participate in the Mentor Program, and what their participation meant to them. The video was played at the end of the business lunch and will be available for viewing on the STSW website. Be sure to check it out!

Personally, I have also had the chance to reflect on how meaningful it was for me to connect with several of my own informal STSW mentors (many in-person for the first time!) while at the conference. Though I could happily expound on the benefits of mentorship at any time, this experience reinforced for me how valuable these relationships are in keeping me engaged, confident, and committed to growth within my profession. I owe so much to these individuals and cannot thank them enough for what they have given me. This theme was additionally reflected in the keynote presentation given by Kay Kendall, in which she recounted her experiences over four decades in transplant social work. It was impactful to hear Kay speak on the importance of mentors as key to providing support, growth, learning opportunities, thus allowing us to endure - and *flourish* - in our complex field. The Mentor Committee couldn't

have asked for a better, or timelier, endorsement!

Public Policy and Resource Updates: Lara Tushla, Chair

It is my pleasure to share that **Hannah Graves** has agreed to take over the leadership of the Public Policy Committee of STSW. We will gradually make that transition. We, as transplant social workers, have unique perspectives which should be taken into consideration as policy decisions are made impacting people facing end stage organ failure. If you would identify areas and opportunities for STSW to weigh in on, please let Hannah or myself know!

Below are some policy matters that you can share your thoughts on:

- <u>Take Race Out of Kidney Transplant Equation</u>. This calls on OPTN to remove the race variable from the Kidney Donor Risk Index (KDRI). The KDRI "scores" kidneys from Black deceased kidney donors less favorably than those from non-Black individuals.
- The National Kidney Foundation believes using race and ethnicity in clinical calculations harms patients and perpetuates racism in kidney care. <u>voices.kidney.org</u>

- Honor Our Living Donors (HOLD) Act eliminates recipient's income from factoring into NLDAC eligibility HE6020.
- OPTN Regional Meetings: <u>Regional meetings</u> -<u>OPTN</u> Regional meetings are held twice each year during the winter and summer public comment periods. Regional meetings are an opportunity to influence policy proposals, prepare for upcoming changes, and hear perspectives from the transplant community about improvements to organ allocation.
- Winter 2024 Public Comment: <u>Public comment -</u> <u>OPTN (hrsa.gov)</u>
  - Public Comment period will be from 1/23/24 to 3/19/24.
  - Will be keeping an eye out for areas we should share our recommendations on
- Living Donor Protection Act (S 1384, HR 2923)
- Living Donor Tax Credit Act of 2023 (S6171) Would provide national refundable tax credit for kidney donation

# **SPOTLIGHT CORNER**



We are delighted to spotlight **Kay Kendall** in this edition of *Society Pages*. Kay, as you will read, has been an exceptionally active member of STSW for more than three decades and has contributed

so much to STSW. Born and raised in South Dakota, she has lived in Cleveland Ohio for thirtyfive years. She received her BA from the University of North Dakota in 1971 and her MSW from the University of Iowa in 1974. She began working for the heart transplant team at the Cleveland Clinic in 1989. In 1991 the team began working with Left Ventricular Assist Devices / Mechanical Cardiac Assist Devices. She worked with both teams as the only social worker for 28 years, and about 6 years ago, she states, two "most wonderful social work colleagues" joined the team.

Kay attended her first STSW conference in 1994 in San Diego and has never missed a conference since then! Her memories of that first meeting include meeting a couple of social workers with whom she maintains close collegial relationships and friendships to this day. She has served on our Board and Executive Committee continually and in multiple capacities, serving as Secretary, as President for five years, then as Past-president, and for the past fifteen years as the National Conference Chair. We have relied on her for her levelheadedness, wisdom, and broad understanding of the local and national issues in our field. In 1998 she became the 7th winner of the STSW *Lee Suszycki Award*.

Kay's contributions to STSW and to the field of transplant social work have been numerous and impressive. She has presented at almost every conference, often delivering workshops for the New Transplant Social Worker – thus introducing and mentoring numerous new transplant social workers to the field. This year, she describes having had the "great honor" of being the keynote speaker – so appropriately presenting the topic "*Four Decades of Transplant Social Work: Past and Present*". She has also published widely in the field of transplant social work – you can see some of her publications listed <u>here</u>. She is proud to have been a helpful colleague and mentor to many social workers.

Kay has become known for her expertise as a transplant social worker. As such she has been afforded the opportunity to present both nationally and internationally, to write chapters in books about transplant, and invited to be involved in the ISHLT (International Society for Heart & Lung Transplantation) Consensus Paper as one of the leaders on the project. Kay credits her involvement with STSW in having her expertise recognized and offered the above experiences. About these opportunities and experiences, Kay states "I learn and gain so much from all of these experiences".

She is actively involved in other professional activities, including: founding and board membership of the Transplant House of Cleveland, leading (x30 years) weekly nursing rounds on the floor where their patients are cared for, leading (x20 years) a monthly support group for pre and post heart transplant patients, collaborating with a nurse



colleague on establishing opioid guidelines for their transplant and LVAD team where they worked to establish an opioid sparing regimen that significantly reduced the use of opioids with these patients.

It's hard to imagine, with all of her involvements, that Kay has room for a personal life ... but she assures us she does. She has been married for 46 years to Gerry Taylor, a pediatric neuropsychologist. They have two sons; Nathaniel Kendall-Taylor, age 45 (an anthropologist who gave the keynote address at the 2021 STSW conference) who is married with three children, and her son Jacob Kendall-Taylor who lives in Chicago and works at JAMA in publishing. She considers herself a "lucky human to have my family" and has a large network of "kind and wonderful friends". Exercise: aerobics, spinning/cycle classes, swimming, running, and hiking, has been part of her life for 50 years, and she makes a point of trying to exercise daily. She has no immediate retirement plans because she loves what she does and feels she continues to make a difference to her patients and to STSW.

Finally, Kay states: "I would be a very different person today if STSW hadn't been a part of my life. I am forever grateful for what I have learned—how I have grown as a social worker and person because of the Society and so happy to have so many dear friends and colleagues that I met because of my STSW involvement."

On behalf of STSW – we thank *you*, Kay, for all you have done for us and for so many.

# SECURING THE U.S. ORGAN PROCUREMENT AND TRANSPLANTATION NETWORK ACT

On September 22, President Biden signed H.R. 2544 into law that will reform how patients are matched to organs. The job formerly held by UNOS for almost 40 years will now be put to bid by multiple competitors. The new law hopes that fostering competition will inject innovation and accountability into the system, ultimately shortening waiting times, addressing racial inequities, and reducing deaths on the waiting list. Officials say their first task is to upgrade the outdated computer system that matches organs to patients; they are now seeking bidders to do that work. The Biden administration has also rolled out a website that will provide detailed, anonymized data on transplant wait lists, donors and recipients, also including outcomes for individual hospitals to help patients and their families make decisions about where to seek care.
